Bequest received

The final payout from the estate of the late Charles LaSalle, former member at St. Paul Ottawa, has been received by WELS-Canada. The amount of \$21,873.72 has been placed in our general operating fund for the time being until further determination by the Board of Directors designates its use on your behalf. The initial bequest of \$137,648 was pooled with Board for Home Missions and Joint Ministry Council subsidies to support our mission start-up in Coquitlam, BC under the guidance of missionary Pastor Qiang Wang. This mission has funding for three years.

WELS-Canada donation to CCCC

The WELS-Canada Board of Directors approved a \$1,000 donation to the Canadian Council of Christian Charities (of which we are a member) defence fund. The monies collected will be used to challenge a case that would allow the courts to intervene in theological decisions of local congregations.
